The book explores these aspects which differ in accordance to the Jain representatives' distinct doctrinal interpretations, forms of organisation and legal and ethical codes. It presents the social history of Jain law and the modern construction of Jainism as an independent religion on the basis of legal documents, biographies, community histories and ethnographies, disputes over religious sites, and interviews with contemporary community leaders in both north and south India. The book fills a gap in the literature and will be an essential resource for researchers interested in Jainism, Indian religions, Indian history, Religious Studies and Law.
